Puerto Rico Investors Tax Free Fund VI, Inc. - Distribution/dividend information

San Juan, Puerto Rico, September 12, 2016: Puerto Rico Investors Tax Free Fund VI, Inc. a closed-end management investment company registered as an investment company under the Puerto Rico Investment Companies Act today announced that the Fund's Board of Directors has declared a dividend from net investment income of \$0.034583 (\$0.034411 exempt and \$0.000172 taxable) per share of common stock. The dividend was paid on September 12, 2016 to common shareholders of record as of August 31, 2016.

Under normal circumstances the Fund invests at least 67% of its total assets in securities issued by Puerto Rico issuers. Shares of common stock are sold exclusively to individuals who have their principal residence in Puerto Rico and to business organizations that have their principal office and place of business in Puerto Rico.

SHARE REPURCHASE PROGRAM. On January 2014, the Board of Directors approved the implementation of a share repurchase program for the acquisition of up to 25% of each Fund's total assets. The Repurchase Program is intended to provide additional liquidity to Fund shareholders. Since the program's inception, the Fund has repurchased 6,875,645 shares of common stock in the open market with an NAV of \$31,704,368, at a cost of \$28,129,812, and which represent 11.78% of the total assets of the Fund (net of Shares acquired for dividend reinvestment purposes and which remain outstanding).
